This L-88 was ordered specifically for road racing. It competed in over 350 competitive events and had an astounding 150 first place finishes.

Its highest accomplishment was in 1970 at the Daytona 24 Hour race. Due to low budget, it was DRIVEN from Kansas to the race by owner/driver Cliff Golio and co-driver Dave Pooley. After posting speeds of 186 mph, the L-88 not only lasted the entire 24 hour race but also finished 2nd in GT class. The Daytona race was completed using the original L-88 block which remains in the car today. In fact, this is the only 67 L-88 known to have its original engine block.

The interior and other original parts were removed when they were brand new) ever since.

Gottlieb sold the retired and tattered racer in 1978. The restoration to race configuration was completed in 1985 by David Burroughs. The car has since been back on the tracks of both Daytona and Laguna Seca in California, but only for demonstration.


**1968 L-88 Coupe**

At the 1968 New Car Show for Chevrolet dealers, Darrell Millisor of Millisor Chevrolet in Belle Center, Ohio, ordered two new L-88's, one bronze and one silver for two brothers. After many production delays some nine months later, the two cars were delivered to the brothers. Both cars were driven daily as the boys finished high school and then college. The bronze car was sold to Bob McDorman for his collection. The silver L-88 later sold to a newspaper reporter in Darlana, Ohio, and is now proudly owned by Ernie Hendry.

After 16 years, in 1987, the two cars were reunited again in this year's field of Bloomington, where during certification, the similarity in serial numbers was noted. They are now reunited again in this year's "SPECIAL COLLECTION".

A State of the Art restoration has brought the car to its original factory delivered condition. It has its original L-88 engine and complete paperwork and history of the car.

This car was Gold Certified at Bloomington in 1987. It was recently photographed for the 1989 Corvette Calendar.




**1968 L-88 Coupe**

Introduced in early 1967 by Corvette News with the caption "Peeched with Caution", the L-88 series was launched. It further stated: "A new super-performance engine has joined the 67 Corvette coral of high-performance power plants. Designed only as an engine for use by qualified, competitive racing groups, a number of radically different features have been adopted to Corvette's already potent 427 cubic inch V8 to make it a "real swinger" for performance buffs."

This early serial number L-88, 17 076, was ordered by East Chevrolet in Seaford, N.Y., but transferred to be delivered to a customer at Giles Chevrolet in Long Island, N.Y. Chevrolet entered the order on February 16, 1967 and built the car body on April 25, 1967. In addition to the L-88 package, the car was also ordered with tinted glass and side pipes.

Upon delivery, the car was then modified for circuit racing with the addition of a roll bar, large shoulder harness and other safety equipment. This is the original factory body, which has never been off the frame and was in unbelievably good condition for restoring. Fortunately, the car was lifted from racing before serious body damage.

The present owner purchased the car in 1979 in Canada. Several years of personal restoration resulted in a Bloomington Gold award in 1985. It has not been shown since.

Corvette advertising said of the 1968 Corvette, "It has got to be one of the most desirable cars ever built." The ad called it the "perpetual emotion machine."

This very well documented 1968 International Blue L-88 was produced on May 29, 1968 and was delivered to its first owner by Jack Maxton Chevrolet in Middletown, Ohio on June 6, 1968.

Though it had five titles in Miami, it wasn't hard for their emotions to become involved with the car. They knew that they had something special. The car has retained its original block, transmission, rear end, interior, a protective tank sticker, warranty book, owners manual and copy of the Corvette order sheet.

Options ordered for the car included the L-88 engine package, tinted glass, telescopic steering wheel, special off road exhaust and wheel covers.

In 1987, the car was purchased by Ron Lowenthal, in a totally disassembled state and the restoration was started almost immediately. Almost all the original parts were there.

This is the first time that this beautiful 31,000 mile car has been put on display.

The 12 mile car. Purchased new in Seattle, college senior Steve Smith dreamed of turning his 67 L-88 into a dragster. He traded it from Alan Green Chevrolet a warehouse, drove it about 176 of a mile and underbody were painted with white epoxy, decals were added and it was slated to receive a one-piece Dana rear end.

After eight years, the project was abandoned. The dream disintegrated. The car never got completed and it never left the warehouse until 1975 when Smith finally sold the car. Lincoln Auto Salvage bought it and sold it to a buyer in Minneapolis who tried to restore the chassis. It then ended a private collection where it remained under cover still undriven.

David Burroughs performed the restoration on this car. Paint-stalking hours were needed to carefully remove all the white epoxy from "everything not painted red" and to restore the chassis and underbody to its 12 mile factory authentic condition.

The exterior red paint and the black interior are unaltered. You will note the original window sticker has never been removed from the window and the door sill reads 12 miles.

This is the lowest mileage "pre-sevens" Corvette known to exist.
